

All that tract or parcel of land lying and being in Land Lot 194 of the 7th District, Gwinnett County, Georgia, and being a portion of Lot 6, Block A, Unit Four, Shawnee Ridge subdivision, and being more particularly described as follows:

BEGINNING at an iron pin located at the northeasterly intersection of the right-of-way of Satellite Boulevard (said road having a 100 foot right-of-way) and Martins Farm Road (said road having an 80 foot right-of-way); thence running north 61 degrees 33 minutes 24 seconds west for a distance of 29.01 feet to an iron pin located on the northeasterly rightof-way of Martins Farm Road; thence running north 17 degrees 58 minutes 12 seconds west along the northeasterly right-ofway of Martins Farm Road for a distance of 240.10 feet to an iron pin and corner; thence running north 72 degrees 43 minutes 56 seconds east a distance of 275.00 feet to an iron pin; thence running south 84 degrees 21 minutes 48 seconds east a distance of 347.00 feet to an iron pin and corner; thence running south 05 degrees 52 minutes 10 seconds west a distance of 280.00 feet to an iron pin located on the northerly right-of-way of Satellite Boulevard; thence running north 82 degrees 38 minutes 51 seconds west along the northerly right-of-way of Satellite Boulevard for a distance of 99.51 feet to a point; thence running along the northerly right-of-way of Satellite Boulevard along a curve to the left having a radius of 1004.93 feet and an arc link of 384.10 feet, being subtended by a cord of south 86 degrees 24 minutes 09 seconds west for a distance of 381.77 feet to the POINT OF BEGINNING; said property contains 3.5660 acres and is shown on that certain plat of survey prepared by Daniel F. Conroy and Associates, P.C. dated February 4, 1994, for State Farm Claim Service Center.

All that tract or parcel of land lying and being in Land Lot 194 of the 7th Land District of Gwinnett County, Georgia and being more particularly described as follows:

TO FIND THE TRUE POINT OF BEGINNING, commence at the intersection of the southeast right-of-way line of Satellite Boulevard (100 foot right-of-way) with the southwest right-of-way line of Lawrenceville-Suwanee Road if said right-of-way lines were extended to form a point instead of an angle; run thence along said right-of-way line of Satellite Boulevard in a westerly direction 265 feet more or less to a 1/2 inch rebar found and the TRUE POINT OF BEGINNING; FROM THE TRUE POINT OF BEGINNING AS THUS ESTABLISHED, leave said right-of-way line and run South 07°21'11" West 328.92 feet to a 1/2 inch rebar found; thence South 59°06'07" West 70.04 feet to an iron pin set; thence North 07°21'11" East 372.28 feet to an iron pin set on the southeast right-of-way line of Satellite Boulevard; thence along said right-of-way line South 82°38'51" East 55 feet to the 1/2 inch rebar found at the TRUE POINT OF BEGINNING.

All that tract or parcel of land lying and being in Land Lots 169 and 194 of the 7th Land District of Gwinnett County, Georgia containing 1.496 acres (being part of Lot 2, Block "B" of Unit Four of Shawnee Ridge Subdivision) and being more particularly described according to a survey for SunTrust Bank, Atlanta, W. Alexis Hoscoso and Constance T. Hoscoso dated April 4, 1996 prepared by Patrick & Associates, Inc., certified by Louis D. Patrick, G.R.L.S. 4 1757, and being more particularly described according to said survey as follows:

BEGINNING at a point on the westerly right of way line of Lawrenceville-Suwanee Road (right of way varies) marked by a right of way monument at the southeasternmost point of the mitre formed by the intersection of the westerly right of way line of Lawrenceville-Suwanee Road (right of way varies) and the southerly right of way line of Satellite Boulevard (120-foot right of way) and run thence along the aforesaid right of way line of Lawrenceville-Suwanee Road South 04 degrees 04 minutes 06 seconds East a distance of 182.81 feet to a point marked by an iron pin found; leaving said right of way line, run thence North 34 degrees 08 minutes 07 seconds West a distance of 39.35 feet to a point marked by an iron pin found; run thence North 69 degrees 21 minutes 47 seconds West a distance of 54.30 feet to a point marked by an iron pin found on the Land Lot line common to Land Lots 169 and 194; run thence along said Land Lot line South 59 degrees 06 minutes 13 seconds West a distance of 290.42 feet to a point marked by an iron pin found; leaving said Land Lot line, run thence North 07 degrees 21 minutes 15 seconds East a distance of 328.92 feet to a point marked by an iron pin found on the southerly right of way line of Satellite Boulevard; run thence along said right of way line of Satellite Boulevard; run thence along said right of way line south 82 degrees 18 minutes 45 seconds East a distance of 42.00 feet to a point; continuing thence along said right of way line and following the curvature thereof an arc distance of 182.92 feet to a point marked by an iron pin found at the northwesternmost point of the mitre formed by the intersection of the westerly right of way line of Satellite Boulevard (120-foot right of way), said arc having a radius of 776.12 feet and being subtended by a chord bearing and distance of South 89 degrees 21 minutes 50 seconds East 182.50 feet; run thence along said mitre South 47 degrees 36 minutes 33 seconds East a distance of 58.07 feet to a point marked by a right of way monument, which poin

To find the Point of Beginning, commence at a concrete monument located on the southeastern end of the mitered corner of the southwest right-of-way line of Lawrenceville-Suwanee Road and the southeast right-of-way line of Satellite Boulevard; thence run in a northwesterly direction along said mitered corner N47°36'39"W for a distance of 58.07 feet to a point located on the northwestern end of said mitered corner; thence run along the southeast right-of-way line of Satellite Boulevard and along the arc of a curve to the right (said curve having a radius of 776.20 feet and being subtended by a chord bearing N89°23'56"W and having a chord distance of 182.50 feet) an arc distance of 182.92 feet to a point; thence continue running along said southeast right-of-way line N82°38'51"W for a distance of 97.00 feet to an iron pin, said point being the TRUE POINT OF BEGINNING:

THENCE from said point as thus established, S07°21'11"W for a distance of 372.28 feet to a point, said point marked by an ½ inch rebar pin set; THENCE S59°06'07"W for a distance of 278.61 feet to a point, said point marked by an ½ inch rebar pin found; THENCE S58°59'23"W for a distance of 36.64 feet to a point, said point marked by an ½ inch rebar pin set; THENCE N16°01'49"W for a distance of 215.37 feet to a point, said point marked by an ½ inch rebar pin set; THENCE N07°21'11"E for a distance of 379.82 feet to a point located on the southeast right-of-way of Satellite Boulevard (right-of-way varies), said point marked by an ½ inch rebar pin set; THENCE along said right-of-way S82°38'51"E for a distance of 186.08 feet to a point; THENCE S07°21'09"W for a distance of 10.00 feet to a point; THENCE S82°38' 51"E for a distance of 146.92 feet to a point, said point marked by an ½ inch rebar pin set, said point also being the TRUE POINT OF BEGINNING.

To find the point of beginning, commence at the intersection of the northwest right-of-way of Satellite Boulevard (100' right-of-way at this point) and the southwest right-of-way of Annandale Lane (60' right-of-way) if extended, thence from said point, South 51 degrees 40 minutes 0 seconds West for a distance of 20.01 feet to a point, said point marked by a half-inch rebar set. Said point also being the TRUE POINT OF BEGINNING.
